

Teachers Looping with Students

It is often related by educators that there are no new ideas just old ideas being recycled. I recently read an article on the internet by Matt Barnun explaining one of these ideas. I used this program for a while more than 30 years ago. I was not an administrator so I was not told why we discontinued the program. The program was called Looping and all it meant was that you moved along with your students -- if you taught them second grade, the next year you taught the same kids third grade.

Researchers from Montana State University and the University of South Carolina discussed a modified model of Looping of third to fifth grade students in North Carolina. In this situation, the entire class did not repeat with the teacher but those that did show a higher gain remained with the teacher the following year.

The authors indicated that there were some noteworthy accomplishments. 1. There is no cost to this program. 2. Statistically black students scored higher in the

program than white students. The reason is unknown but it may be worth it in an effort to try to help that group. 3. The teachers with the biggest improvement in scores were generally the teachers that had been the lowest performing. 4. All students seem to benefit because the classroom environment seemed to improve. and 5. A trust between teacher and home has already been established and the ability to speak openly comes easier even for new kids to the program.

There are not many studies but all are consistent in showing at least moderate success. When I taught in this program, I felt I had a better beginning to the school year because we already knew what to expect and were able to continue progressing. The problem with CPS is that we were constantly given new programs. Every time we got new leadership (and there were a lot of them) they believed they had the answer, but we were seldom in a program long enough to accurately assess it. A little consistency could go a long way to helping solve the problems of low progress among our public school kids.

IDPH Warning For Romaine Lettuce

The Illinois Department of Public Health, along with the Centers for Disease Control and Prevention, the Food and Drug Administration, and other state and local health departments, is expanding its investigation of a multi-state cluster of E. coli infections to include not only chopped romaine lettuce, but full heads and hearts of romaine lettuce.

Information collected to date indicates that romaine lettuce from the Yuma, Arizona growing region could be contaminated with E. coli O157:H7. At this time, no common grower, supplier, distributor, or brand has been identified. The investigation now not only encompasses chopped romaine lettuce, but all romaine lettuce from the Yuma, Arizona region.

Cases have been reported in 16 states with 31 hospitalizations and no deaths.

Consumers who have store-bought romaine lettuce at home, including salads and salad mixes containing chopped romaine lettuce, should not eat it and should throw it away.

People usually get sick from Shiga toxin-producing E. coli 2 to 8 days after swallowing the germ. Most people infected with E. coli develop diarrhea (often

bloody), severe stomach cramps, and vomiting. Most people recover within one week although some illnesses can be more severe, resulting in a type of kidney failure called hemolytic uremic syndrome.

Talk to your health care provider if you have symptoms of an E. coli infection and report your illness to your local health department. You can also write down what you ate in the week before you started to get sick and talk to public health investigators if they have questions about your illness.

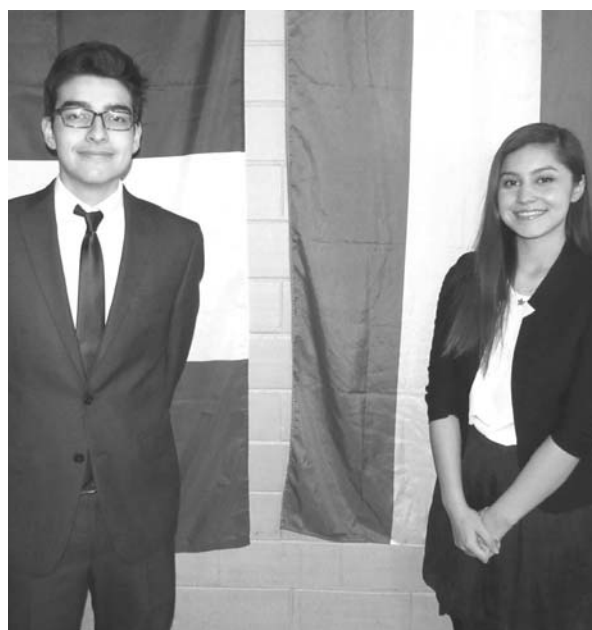

Unemployment Rate Dips in March

The Illinois Department of Employment Security announced that the unemployment rate decreased by -0.1 percentage point to 4.6 percent in March and nonfarm payrolls decreased by -2,100 jobs over-the-month, based on preliminary data provided by the U.S. Bureau of Labor Statistics (BLS) and released by IDES. The February job gain was virtually unchanged from its initial report. (+15,300 jobs versus +15,200 jobs).

Job growth improved in the January to March period posting average monthly gains of +4,000 jobs, an increase over the prior three-month period (October to December 2017) with average monthly gains of +2,200 jobs.

Over-the-year, non-farm payroll employment increased by +39,200 jobs with the largest gains in these industry sectors in March: Manufacturing (+18,200); Financial Activities (+7,800); and Government (+6,800). The industry sectors with the largest over-the-year declines include: Information Services (-4,600); Professional and Business Services (-2,700); and Other Services (-1,200). Illinois nonfarm payrolls were up +0.6 percent over-the-year in sharp contrast to the

nation's +1.5 percent over-the-year gain in March.

The state's unemployment rate is +0.5 percentage points higher than the national unemployment rate reported for March 2018, which held at 4.1 percent. The Illinois unemployment rate is down -0.4 percentage points from a year ago when it was 5.0 percent. The Illinois jobless rate last stood at 4.6 percent in March 2007.

The number of unemployed workers decreased -2.5 percent from the prior month to 297,700, down -7.5 percent over the same month for the prior year. The labor force was unchanged over-the-month, but it was up +0.1 percentage points over the prior year. The unemployment rate identifies those individuals who are out of work and are seeking employment.

An individual who exhausts or is ineligible for benefits is still reflected in the unemployment rate if they actively seek work. To help connect job-seekers to employers who are hiring, IDES' maintains the state's largest job search engine, IllinoisJoblink.com (IJL), which recently showed 59,539 posted resumes with 184,089 jobs available.

Arachnid Exhibit At Brookfield Zoo



This summer, guests visiting Brookfield Zoo will have an aMAZEing time weaving their way through a new temporary exhibit—Amazing Arachnids. The interactive and engaging experience, which opens May 26th and continues through Sept. 3rd, features two components: Art and Science of Arachnids and Mission Safari Maze.

Arachnids reveals the marvels of eight-legged critters featured in three themed areas that highlight their unique characteristics and significance. The art-themed portion illustrates their importance in music, literature, and film. The culture-themed space focuses on conservation, folklore, and mythology.

The final section explores arachnids in relation to science and medicine. 100 live arachnids, including the tiger rump tarantula, emperor scorpion, the alien-looking tailless whip scorpion, the beautiful peacock tarantula, burgundy goliath birdeater, and goliath pinkfoot tarantula are displayed amongst the three sections.

A variety of hands-on interactivities and opportunities for guests of all ages include weaving a web, assembling puzzle pieces to create a unique spider, learning an Italian folk dance called the Tarantella, and controlling the movements of a tarantula at the Arachnid Mobility station that features two computer monitors. In the Arachnid Art Gallery, zoogoers can view images by world-renowned German arachnid photographer Julian Kamzol.

Animal care staff will bring the nuances of the species to life with facts and lively tales during spontaneous Zoo Chats. Guests will learn what

arachnids eat, how they survive in the wild and what are their natural predators.

Mission Safari Maze blends education along with physical activity, making it a unique learning adventure for guests of all ages. The interactive attraction connects guests to the stories and strengths of 16 species of animals that can be seen including the bison, Amur tiger, Andean condor, bald eagle, black rhinoceros, black widow spider, Blanding's turtle, Bornean orangutan, emperor scorpion, green-winged macaw, Indian peafowl, Orinoco crocodile, peacock tarantula, red knee tarantula, reticulated giraffe, and white-bellied pangolin.

Throughout the maze there are play-and-learn interactives, including a climb-on spider web, jungle vines, swinging bars, and a monorail zip slide.

"Animal Secrets" At Children's Museum

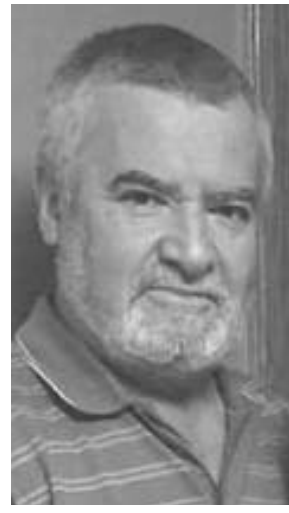

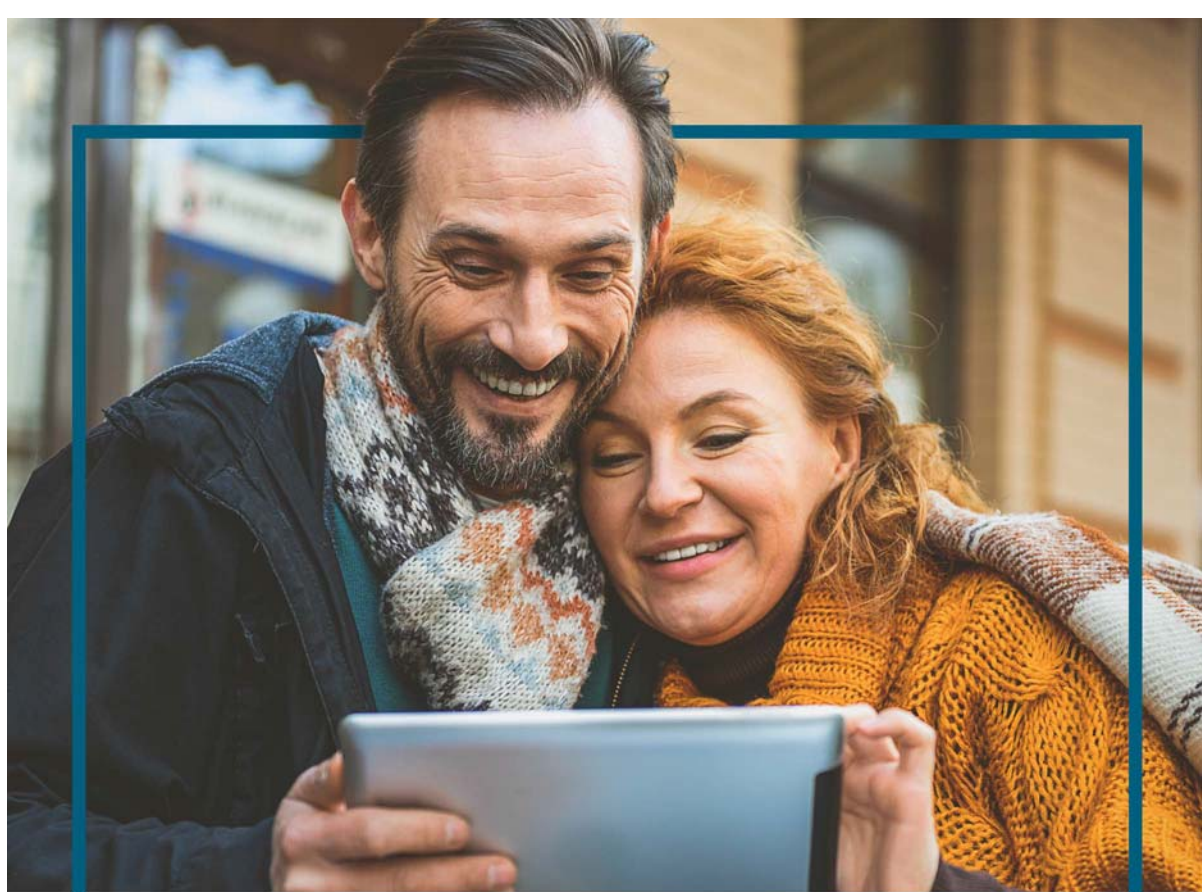
