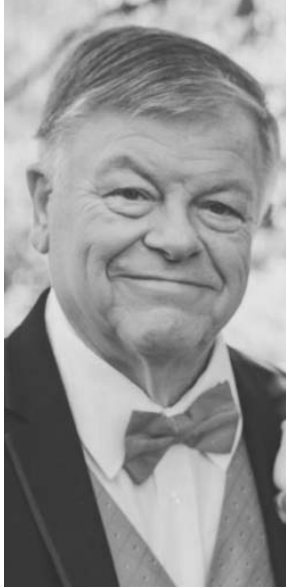


## 75th Anniversary Of D-Day

We worry about our students losing the understanding of the importance of the US in our world. Many students do not understand the sacrifices the people of the United States made to defeat Nazi Germany and its allies along with the Empire of Japan -- and we kept nothing. We even kept troops to help others regain their freedom from the Soviet Union.

While the teachers are much younger now and have no first hand knowledge, I found a great opportunity for them to teach our students now as we approach the 75th anniversary of D-Day when over 350,000 soldiers and sailors began to push the Germans out of France.

The movies, *The Longest Day* and *Saving Private Ryan*, are the way many know this time because most of the veterans have passed on to their final reward. The National World War II Museum in New Orleans is hosting an electronic field trip. Learners are invited to a virtual adventure with student reporters from the United States, Canada, England and France from the very sites where the D-Day history was made. This is a free event and will stream live on Thursday, May 2nd, at 6:00, 9:00 and noon Central time. I had the opportunity to go with my wife and kids to Normandy in 1999 for the 65th Anniversary. It was amazing to see that the French dress in US uniforms much like we see those commemorating the North and South in the Civil War in places like Gettysburg. Don't let some of these modern politicians slight these people -- others don't. One of the most tender heartfelt tears came when we were at the American Cemetery in Normandy, just off the beach, it's the same one shown in *Saving Private Ryan*. ## Park District Opens Registration

Chicago Park District's online registration for its summer day camp and park programs is now open. Regular programs run the week of June 17th through the week of Aug. 19th while standard day camps run for six weeks from June 24th through August 2nd.

This year, the summer day camp curriculum will celebrate the District's 85th and engage campers in activities and education programs as well as weekly physical fitness routines.

Day camp will provide the opportunity to participate in energetic team building and cooperative games, visual arts and writing activities, outdoor and environmental education, performing arts and imaginative play, and active games and fitness activities.

In-person registration for summer programs will begin Saturday, April 27th or Monday, April 29th, depending upon the park.

Standard day camps, for ages 6 to 12 years old, run six weeks, from June

24th to Aug. 2nd, typically from 9 a.m. to 3 p.m. or 10 a.m. to 4 p.m., Monday through Friday. Play Camp offers options for children ages 3 to 5 years old, and Teen Camp for participants ages 13 to 15 year olds.

Numerous specialty camps are also available, including Sports Camps. Late Summer Camps offer extended opportunities to engage in park activities from Aug. 5th to 9th or 16th; date varies by park. Early bird and extended options offer convenient hours to cover the full day.

Online registration for gymnastics centers is now open. Summer program registration for McPetridge Sports Center & Morgan Park Sports Center opens Tuesday, May 28.

Fees vary depending on location, offerings and hours. No child will be turned away for inability to pay.

## Unemployment Rate Up Slightly in March

The Illinois Department of Employment Security announced that the unemployment rate was 4.4 percent in March, up +0.1 percentage point from the prior month, and nonfarm payrolls were down -2,800 jobs over-the-month based on preliminary data provided by the U.S. Bureau of Labor Statistics. The February jobs loss was revised downward from the preliminary report (from -12,600 to -10,800 jobs).

Average payroll employment growth during the January to March

sectors with the largest payroll declines were: Professional and Business Services (-4,200), Trade, Transportation and Utilities (-3,000) and Construction (-1,600).

Over-the-year, nonfarm payroll employment increased by +47,400 jobs with the largest gains in these industry sectors in March: Education and Health Services (+14,000), Manufacturing (+9,000), and Professional and Business Services (+8,400). The industry sectors with over-the-year declines were: Construction (-4,700), Information (-2,900) and Mining (-200). Illinois nonfarm payrolls were up +0.8 percent over-the-year as compared to the nation's +1.7 percent over-the-year gain in March.

The state's unemployment rate is +0.6 percentage points higher than the national unemployment rate reported for March 2019, which remained at 3.8 percent. The Illinois unemployment rate is up +0.1 percentage point from a year ago when it was 4.3 percent.

The number of unemployed workers increased from the prior month, +1.1 percent to 284,400, and was up +1.3 percent over the same month for the prior year. The labor force was about unchanged over-the-month but was up +0.1 percentage point over-the-year. The unemployment rate identifies those individuals who are out of work and are seeking employment.

An individual who exhausts or is ineligible for benefits is still reflected in the unemployment rate if they actively seek work. To help connect jobseekers to employers who are hiring, IDES maintains the state's largest job search engine, IllinoisJoblink.com, which recently showed 62,954 posted resumes with 98,957 jobs available.

### Safe Routes To School Grants

Governor JB Pritzker and the Illinois Department of Transportation announced the award of more than \$5.5 million to local communities for projects that encourage students to walk or bike to school. The 39 projects, made possible through IDOT's Safe Routes to School program, were selected from 160 applications received from across the state.

Administered by IDOT using federal funds, Safe Routes to School supports projects and activities that improve safety and reduce traffic in areas around elementary and middle schools. Improvements can include new sidewalks, efforts to reduce speeding and other traffic offenses, public education and outreach programs.

### Increase For Distemper Virus

Cook County Animal and Rabies Control is advising pet owners to protect their pets from distemper virus. The department has seen an increase in cases of confirmed canine distemper virus found in raccoons tested after displaying abnormal neurologic signs.

The distemper virus affects the respiratory, gastrointestinal and nervous system of dogs. Symptoms can include ocular and nasal discharge, sneezing, coughing, lethargy, loss of appetite, vomiting, diarrhea, tremors and seizures. Death can occur from secondary pneumonia or non-responsible seizure activity.

The surveillance program for wildlife diseases in Cook County monitors rabies infection and other zoonotic diseases in wildlife and it also detects trends in diseases that can be spread to companion animals.

Cook County Animal and Rabies Control urges pet owners to vaccinate their dogs and prevent contact with wild animals.

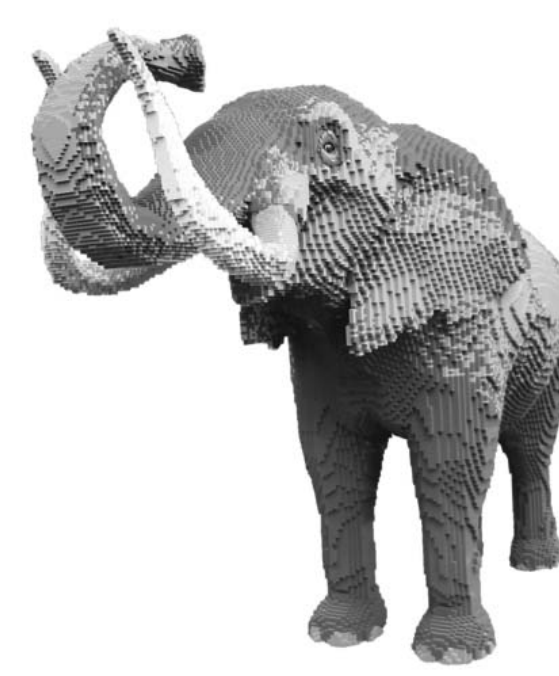
