VoD Essay Contest For Scholarships

Commander John Davin of the Veterans of Foreign Wars Department of Illinois announced the kick-off of the 68th year of the Voice of Democracy Scholarship Competition. Local high school students have the opportunity to compete for scholarships and a trip to Washington, D.C.

Students begin by competing at the local Post level with a deadline of Nov 1st.

Post winners advance to District and then the first place District winner advances to the state competition. All state winners receive a four day trip to Washington, D.C. A total of \$152,000 is awarded to national finalists. First place is a \$30,000 college scholarship.

Annually the VFW provides more than \$2 million in scholarships. Each year, around 40,000 students participate in the competition.

Students must write and record a three-to-five minute essay on the theme "Why Veterans are Important to our Nation's History and Future" on an audio cassette tape or audio CD and present their recording, typed essay, and entry form at their local VFW Post.

Book Donation For Shields School

Returning for third year is *Club 615*, a free pre-concert lecture series, hosted by Derek Matson, that takes place every Saturday night through the season at 6:15 p.m. in the Choral Hall, on the east side of the Jay Pritzker Pavilion.

Open lunchtime rehearsals of the Orchestra and Chorus take place Tuesdays through Fridays from 11 a.m. to 1 p.m. Audiences are welcome to sit in the Pavilion Seating Bowl during

rehearsals and docents will talk about the week's concerts during rehearsal breaks.

On Fridays at 5:30 p.m., before the Grant Park Orchestra takes the stage, audiences will be treated to concerts by students from local music schools and summer music programs at the front of the Great Lawn at the Jay Pritzker Pavilion.

Education

Schools are year-round business. And the misconception that school news is during the school year often allows regulations to pass without much vocal concerns from those concerned. The public is becoming more aware of this as became evident when I attended a meeting hosted by the McKinley Park Progressive Alliance.

This well-attended meeting had many representatives from organizations throughout the area including the Brighton Park Neighborhood Council, Bridgeport Alliance, McKinley Park Civic Association, Chicago Teachers' Union, and 12th Ward Alderman George Cardenas. Also in attendance were members of many Local School Councils, a few people who were running for political office, and a student organization.

When listening to the speakers, which Bill Drew did a good job of letting as many as wanted to speak to express their concerns, it became evident there was a wide political range of those in attendance. During conversations before and after the meeting, this range became evident. There were those who wanted the minimum-wage raised and businessmen who said the raise would put them out of business. There were pro-life and pro-abortion people, there were union and anti-union, and most other issues of interest to the general public. But these people came together in their concerns for schools.

This large, diverse group was apparently unified in support of a Chicago Teachers' Union

resolution to halt new charter schools that are being considered. Many worried about the tax drain on existing public schools, others about the issues made known to the public by newspapers. The recent articles have indicated that the Concept Charter Schools, which runs Horizon and a proposed new school at 54th and Western, have had trouble nation-wide, with schools being closed and rated very poorly in several states. The FBI is investigating many from this charter conglomerate and it was felt that no new charter schools should be open until the resolution of the current investigation. They also pledged to be vigilant of zoning changes that allow charter schools to move into properties not made for that purpose.

The people running the meeting allowed everyone to speak and told those present that they would advertise their next meeting. It is also worthy to note, that as one speaker said, you don't have to be a parent to be concerned about education.

14th Ward Alderman Edward M. Burke announced that Kedzie Ave. will be closed to all vehicular traffic for the next six months between 48th and 49th place to allow for extensive viaduct improvements.
