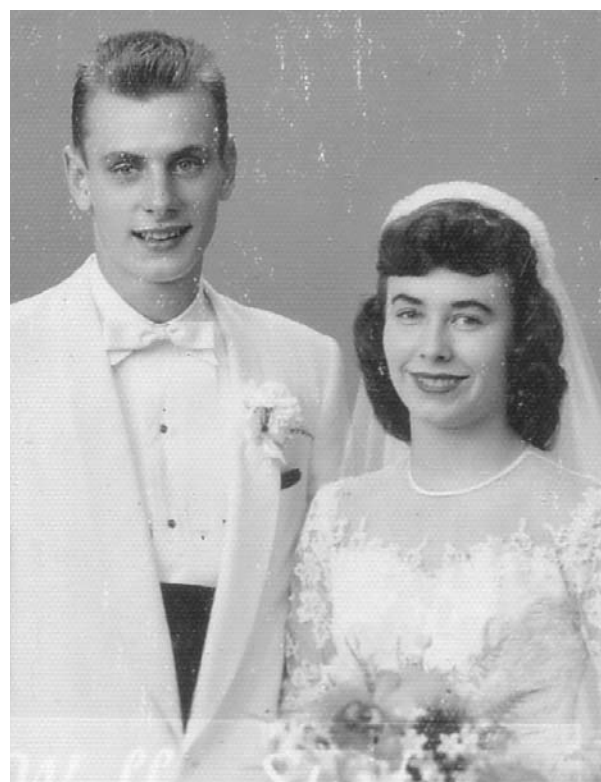


9/11 Remembrance

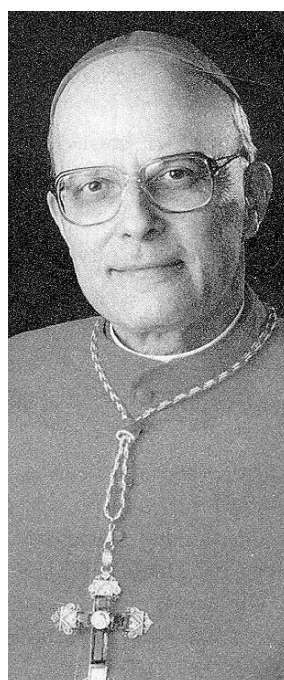

5K Run + Walk At Brookfield Zoo

Don't be surprised if on September 25th you see balloons and signs in front of our area Catholic schools, or at the State of Illinois Building. It is a school choice rally. The Archdiocese of Chicago is attempting to educate the public on the true savings the school system is to our area. In Cook County, they estimate the savings to the tax payers of at least \$400 million in 2013. That doesn't include the use of all the buildings.

When my children were at McKinley Park Catholic, I testified at State Rep. Martinez's hearing about State Aid to Catholic schools in Pilsen. I testified against it because I felt that the State never gives you a dollar without expecting something in return. Now the political climate is constantly calling for choice.

The Catholic Schools produce this choice. So as you look at this issue, the school children could have good reports using the following facts: A. There is nothing in the US or State Constitution calling for the separation of Church and State.

B. The Courts have already ruled that aid to religious schools helps children, not the religion. C. Catholic schools no longer have a surplus of Sisters that made education affordable to almost everyone.

D. Charter schools were introduced as a cheaper way to educate. Now these schools receive the same funding as the public schools. E. Charter schools are being touted by many of our politicians as being an offering of choice.

F. Charter schools have been named in the

Sun-Times as given our State politicians free junkets to Turkey and other places. I'm sure they would go nuts if the Archdiocese tried this with tax money.

G. The charter schools have helped close neighborhood private schools, therefore, where is the choice?

I am sure the educators in our community can think of even other facts to have the students consider, but these should help you consider this the issue.
