Assessor Explains Tax Exemptions

Cook County Assessor Fritz Kaegi reminds sen-ior homeowners to apply for their property tax-sav-ing exemptions before the April 21st deadline. Exemptions provide homeowners savings on their property tax bill. Senior homeowners are eligible for two main exemptions:

exemptions: The Senior Exemption is available to those 65 years of age or older who occupy their property as their principal place of residence. This exemp-tion automatically renews every year. "Senior Freeze"

Exemption is available to all who receive the Senior Exemption and had an annual household income of \$65,000 or less in 2023. Homeowners must reap-ply for this exemption



Calls For Property Tax Predictability

The Cook County Assessor's Office hosted annual Market Investor Day event on Wednesday, April 2nd, with Cook County Assessor Fritz Kaegi and outside panelists dis-cussing the need for better predictability in the Cook County property tax system.

"Let's think about how much better our situation would be if we could put changes in place that would provide greater predictability," said Assessor Kaegi. "The system that many of us work in and that all of us interact with is one where commercial property owners keep on filing appeals. And these appeals, on the whole, don't improve outcomes."

Assessor Kaegi noted


